

## BALDWIN TOWNSHIP SPECIAL MEETING

March 23, 2010

**Present** – Supervisors Larry Handshoe, Jeff Holm, Jim Oliver, Tom Rush and Jay Swanson.

**Call to Order** – The March 23, 2010 special meeting of Baldwin Township was called to order by Chairman Jeff Holm at 7:03 pm

**Pledge of Allegiance** – All present recited the Pledge of Allegiance.

**Approve/Disapprove Maintenance Start/End Times and Summer Hours** – Swanson/Handshoe unanimous to set summer maintenance hours starting May 15 through September 1 as Monday through Thursday from 7:00 a.m. to 3:00 p.m, and a ½ hour unpaid lunch per day for a total of 30 hours each for Terry Carlile and Zachary Good.

**Approve/Disapprove 2010 Road Projects** – Swanson/Handshoe unanimous to crackseal the SW corner which includes Sections 19, 20, 21, 30, 29, 28, 31, 32 and 33. Friendly amendment accepted to include Bogart determining the type of cracksealing needed. Bogart is to determine the amount of money needed before going out for bids.

Oliver left at 8:03 and returned at 8:06.

Swanson/Handshoe unanimous to approve repairs to 99 ½ Street at the north end of Sandy Lake for a cost of approximately \$25,000.

Handshoe/Swanson unanimous to chipseal and sealcoat 125<sup>th</sup> Street from 321<sup>st</sup> Avenue (County Road 28) to 313<sup>th</sup> Avenue and the north section of 126<sup>th</sup> Street from 320 – ½ Avenue, 319<sup>th</sup> Avenue and 126<sup>th</sup> Street. Total would be approximately one and one-half mile. All roads would include striping (including Railway Properties) and fog lines. The striping would include 313<sup>th</sup> Avenue from Highway 169 to County Road 45. The township would be spending up to \$35,000.

Oliver left at 8:27 p.m.

There was discussion coordinating 112<sup>th</sup> Street road work with Livonia Township. Handshoe/Swanson unanimous to pursue and work with the engineer. Holm will contact Livonia with information for the April meeting.

**Schedule Closed Meeting with Fire Chief & Assistant Chief** – Handshoe/Rush unanimous to schedule a closed meeting with the fire chief and assistant fire chief on Wednesday, March 31, 2010 at 6:00 p.m.
